SOME **BACKGROUND** TO ASPASA

Mankind is driven by a natural inclination to shape, develop and improve the environment in which they live and work.

Since the beginning of time, these goals have been achieved through association; people of similar interests coming together to form bodies that are designed and destined to represent their common interests. Through these associations, whole industries evolved recognizable codes of conduct, ethical foundations, self regulatory practices and lobbying skills, techniques and practices to the benefit of their members, their industry and indeed the society in which they operate.

The history of ASPASA in South Africa is a history of gradual association. From the early years of family owned businesses geographical dispersed around the country, the growth of the industry has been paralleled by the amalgamation of these businesses into larger companies.

As time went by, the need for the formation of a professional body arose, to take up issues on behalf of the industry and to co-ordinate industry opinion. A number of geographical diverse associations were formed. Despite their best intentions, the officers of these associations were unable to devote the time or the energy required to successfully achieve their mandates. These frustrations were compounded by the fact that individually they could not command the necessary creditability with the authorities.

In a momentous meeting of the captains of the quarrying industry in March 1990, a steering committee was duly appointed to formulate the functions of a new body with the inclusion of full-time staff. As a result, ASPASA was formed on August 23rd of that same year.

THE **POWER** OF ASSOCIATION

ASPASA's membership is made up of large and small operations working together for the betterment of the South African industry as a whole.

ASPASA's enormous power as an advocate on industry is largely due to its committee system. These committees are dedicated to providing members with data and learning forums to keep abreast of industry issues, as well as providing firm input into the policies and positions governing ASPASA and the industry.

Aspasa deals with issues that do not allow members to collude. Issues such as market share, product prices, etc, are not entertained at any of the Aspasa meetings.
